To be selected, all nominees must go through stringent judging process including supporting documents check, meeting with the representatives of Enterprise Asia and a final report prepared by the representatives to the judging panel. Then, the judging panel will further analyze the nominations based on the criteria such as evident business growth, market competitiveness, innovation of products and services, leadership qualities and entrepreneurial spirits, as well as vision and strategic direction.

No company can be succeeded with only one man's work. Mr. Lap Man has a motto: "The best of nature is pure like water." He added: "I am more than willing to listen to suggestions coming from all levels of DYXnet Group with my motto saying the highest wisdom is able to accumulate from the crowd with peace in mind.
